

Privacy and cookie information

This document contains basic information on the handling, processing and registration of the personal data of www.phenogyde.com users of the website (hereinafter referred to as "User"), as well as the users' rights in this regard and the possibilities of enforcing them.

1. Data controller's data

There is no data protection officer at the controller, the controller is not obliged to appoint a data protection officer pursuant to Article 37 of the GDPR.

The Controller of personal data (BlazeArts Kft. ; 1096 Budapest, Thaly Kálmán u. 39. - Operator) as a data processor entrusted by the data controller, is stored on dedicated servers protected by guarding in the territory of the European Union. The data provided by the User is recorded by the Operator in an electronic internal register, which is accessed only by the Operator's employees. The Operator does not use the data for any purpose other than that indicated in this policy. Personal data will be disclosed to third parties only with the prior and informed consent of the user. This does not apply to possible data transfers that are legally mandatory. Personal data will not be transferred outside the European Union.

2. Legal basis, scope, purpose and duration of the data processed during the filling in the contact form

Persons **involved** in data processing : individuals filling in the contact form or subscribing to the newsletter

Processed data: name, e-mail address and company name

- **PURPOSE OF DATA PROCESSING:** Sending an information newsletter, contacting
- **LEGAL BASIS FOR DATA PROCESSING:** Consent of the data subject pursuant to Article 6 (1) (a) of the GDPR
- **DURATION OF DATA PROCESSING:** 5 (five) years from the date of submission of the contact form or unsubscribing from the newsletter;

3. Rights of the User

The User may request information about the processing of his data, the purpose / legal basis and duration of data processing at any time, request the processed data, request the correction or deletion of his personal data at the above contact details of the Data Controller. The correction or deletion shall be carried out by the Operator within 5 working days after receipt.

The User may object to the processing of his/her personal data in the cases specified by applicable law.

4. Cookies used on the website

We use Google Analytics cookies on the website to analyze our website traffic (<https://policies.google.com/privacy>). Cookies are small text files that a website can use to make the user experience even more efficient. According to the law, cookies may be stored on your device if this is strictly necessary for the operation of our website. To use all other types of cookies, we need your permission.

You can change or withdraw your consent to the Cookie Statement on our website at any time.

5. Remedies

Anyonewho believes that their rights have been violated as a result of the data processing of the data controller can go to court or complain to the Authority (National Authority for Data Protection and Freedom of Information; headquarters: 1055 Budapest, Falk Miksa utca 9-11.; Phone: +36 (1) 391-1400; e-mail: ugyfelszolgalat@naih.hu) can be contacted.

The court shall deal with the case as a matter of priority. The Metropolitan Court of Justice has jurisdiction over the lawsuit, but the lawsuit may also be brought before the court competent for the place of domicile or residence of the person initiating it, at the choice of the person who initiated it.
